have a non-emergency issue. Also, remember to take the regular precautions of not leaving valuables in cars and remembering to close garage doors and lock doors at nighttime.

# ACC Inspections: That time of year!

As the weather improves, the ACC inspections will be more thorough than they have been during the winter. Inspections are done on a monthly basis with courtesy notices sent out by Windermere.

The most cited violations include the following:

- weeds in landscaped beds or in driveways and sidewalks
- lawn not mowed and edged
- trash bins stored in sight of the street.

If you are elderly or are short on time, consider hiring a neighbor's son or daughter to help out as a summer job. Neighbors on your street would probably also be willing to lend a hand if your mower breaks down or you need an edger, or even if you just need some friendly lawn care advice.
